**TREE PRUNING/REMOVAL REQUEST
INFORMATION FOR APPLICANT

City of Clovis Municipal Code

10.1.06 Permit to remove and trim trees and plants.

No person shall cut, trim, prune, plant, remove, injure, or interfere with any tree, shrub, or plant upon any street, park, pleasure ground, boulevard, alley, or public place of the City without the prior permission and approval of the Public Utilities Director. The Public Utilities Director is hereby authorized to grant such permit in his discretion and, where necessary, subject to the condition that the removed tree be replaced by an official tree in conformity with the street tree plan. No such permit shall be valid for a longer period than thirty (30) days after its date of issuance. (§ 9, Ord. 218, as amended by Ord. 946, eff. March 24, 1994)

Replacement of Removed Trees

It is recommended that any tree that is removed from the Parking Strip be replaced and relocated within the front yard area of the residential property (provided there is enough space) with trees from the City of Clovis Tree List.
