

2010 BUSINESS LICENSE RATES

If Your Business is Located Within the Clovis City Limits

Minimum license fees will be prorated to the calendar quarter in which business is started. The maximum annual license fee is \$6,804.00. The business license fee will be the calculated rate (based on the estimated gross receipts for Clovis listed on your application) or the minimum license fee, (see below) **WHICHEVER IS GREATER**. Your business will be classified in accordance with the Standard Industrial Classification (SIC) Manual. If your business is located within the Downtown Parking and Business Improvement Area (PBI) additional fees will apply.

Business License Fees for New Businesses (Yearly and Pro-rated per Quarter)

If Purchased between – January 1 to March 31 (1 st Quarter)	-	\$167.00
If Purchased between – April 1 to June 30 (2 nd Quarter)	-	\$125.25
If Purchased between – July 1 to September 30 (3 rd Quarter)	-	\$ 83.50
If Purchased between – October 1 to December 31 (4 th Quarter)	-	\$ 41.75

The minimum business license fee for existing businesses is \$167.00 per year.

If your business is located outside the Clovis City Limits

Out-of-City Contractor Rates

The license fee for Contractors and Sub-Contractors working in the City of Clovis is \$1.00 per every \$1,000.00 of the total gross amount of the job in Clovis or the minimum for the current quarter, **WHICHEVER IS GREATER**.

Work done January – March (Minimum)	=	\$41.75
Work done April – June (Minimum)	=	\$41.75
Work done July – September (Minimum)	=	\$41.75
Work done October – December (Minimum)	=	\$41.75

If you are working in Clovis during more than one (1) quarter, the minimum fee is \$41.75 for each quarter or the annual fee of \$167.00.

Service Delivery Businesses

If you are a service/delivery business, your license fees will be based on the size and number of vehicles coming into Clovis and the frequency of trips.

Over Two (2) Tons	Once a week	\$ 52.50
	Twice a week	\$ 63.00
	Three or more times a week	\$ 76.00
